2 JOB PURPOSE

To provide an effective counselling service to parents and other adult family carers who care for a disabled child. The post is funded by the National Lottery Community Fund as part of the Grace House One Place, Your Space project. The project outcomes for people who use the project are to: improve emotional resilience; reduce social isolation; improve family relationships; reduce their reliance on statutory services.

- To carry out an initial assessment to ensure the suitability of the potential client to enter into a contracted counselling agreement with Grace House
- To provide an excellent counselling service within the 10 session model used by Grace House in the One Place, Your Space project
