Post title:	Child and Adolescent Psychotherapist
Payscale:	N10 Term Time Only
Responsible to:	CEO & Trust Parenting Lead

## Job purpose:

- To provide a specialist child and adolescent psychotherapy assessment and treatment service for children, adolescents and their parents/carers and families who may be experiencing severe, highly complex and persistent behaviour and emotional difficulties and/or associated mental health problems.
- Under the direction of the Executive Leadership Team, to contribute to the development of child psychotherapy services within the Trust.
- The post holder will embrace the core values of the organisation and adopt the principles of Recovery. These principles will recognise the need to:
  Promote safe practices
  - •Value the aims of service users
  - •Work in partnership and offer meaningful choice
  - •Be optimistic about the possibilities of meaningful change •Value social inclusion

## Main responsibilities

The following list is typical of the level of duties that the post holder will be expected to perform. It is not necessarily exhaustive and other duties of a similar type and level may be required from time to time.

- 1. Carefully observe children and young people and respond to what they might be communicating through their behaviour and play
- 2. Provide assessment and treatment of children and adolescents as individuals or in a group
- 3. To keep clinical notes and make reports for all referred students when required.
- 4. Provide a tailored approach to the individual child and work in an ageappropriate way.
- 5. Provide short-term and long-term interventions with children, young people and/or parents, from a few sessions to regular appointments over several years



- 6. Work alongside other professionals in planning how best to help a child and the child's family.
- 7. Work as part of multidisciplinary teams
- 8. To be an active member of the trust's team and as such provide information and training to the community, that supports the therapeutic environment of the trust.
- 9. Supervise trainee child psychotherapists and other therapists where appropriate
- 10. Plan service delivery in conjunction with Trust Parenting Lead and develop new services
- 11. Keep up to date with developments in theory and research and undertake continuing professional development (CPD).
- 12. Under guidance from the Trust Safeguarding Lead to ensure Policies and Procedures in relation to Safeguarding are kept up to date.
- 13. To ensure that all activity and interventions are appropriately recorded.
- 14. To attend training courses appropriate to the post in order to enhance personal and professional development, as well as to increase the quality of the service delivered by the organisation.
- 15. To agree work objectives and strategies with the appropriate persons.
- 16. To promote and implement the school's Equality Policy in all aspects of employment and service delivery
- 17. To be aware of and adhere to requirements of the Corporate Health and Safety Statement
